*Under section 4.14.C of the Hopi Education Code, the Hopi Board of Education may call a meeting into Executive Session at its discretion to “review materials or to discuss, but not act upon, sensitive or confidential matters. Executive sessions shall not be open to the public.”*

3. Action Item #14-22 to adopt Two-Year Transition Plan for the Hopi School System:

**Plan for 2022-2023 SY:** Schools remain under their existing local school boards, policies and procedures and enter contracts in Spring 2023 for the 2023-2024 SY with provision to transfer/assign contracts to the HBE once the Hopi School System PL 100-297 grant is approved.

**Plan for 2023-2024 SY:** HBE becomes the school board for all of the schools under the HSS policies and procedures. Schools use their existing administrative services and staff but begin to work with the Central Administration Office and the HBE to begin using the Infinite Visions software *[if it is approved]* and HSS policies and procedures. Schools may use their existing curriculum if already under contract but others may begin using standardized curriculum and standards. Attendance Area Policy comes into effect requiring students to attend the school of their residence, but parents may apply for a waiver for one more year to attend the school of their choice to assist in the phase in of the policy.

**Plan for 2024-2025 SY:** Schools are fully transitioned with the HBE as the school board for all schools, standardized curriculum/standards at all schools, Infinite Visions *[if it is approved]* being used by all schools, and Central Administration Office is fully or nearly fully staffed providing centralized administrative services to all schools. Attendance Area Policy requires students to attend the school of their residence, unless student has a waiver. Transportation will not be provided for students with a waiver.

4. Updates on recent Hopi Board of Education actions and events:

- a. HBE has conducted 5 Town Halls with the schools and local villages to date and participated in 1 school staff orientation, and will conduct 2 more Town Halls in August with HBCS (August 25, 2022, 5:30 p.m.), and HDS (August 30, 2022, 6:30 p.m.).
